

#LIFEFORCE – TERMS & CONDITIONS



The following terms and conditions apply to all companies and or persons or other entities (“you”) that are taking part in the #LifeForce online programme (“Programme”) organised by Taz Thornton and her associates (“we” or “us”). Please ensure you have read and understand the following:

1. Acceptance Of Terms And Conditions

By booking your place for this programme, you are agreeing to the terms and conditions set out below (“Terms”) and they will be incorporated into the contract between us (“Contract”). You will ensure that your employees, partners, agents, contractors, subcontractors or any other person attending the Programme on your behalf shall comply with these Terms. The Contract is formed when you sign up to the programme online, or receive a payment/booking confirmation via EventBrite, Paypal or email, or any other electronic communication.

2. Payment

If payment has been made in full, this acts as your time reservation fee for the entire Programme and is non-refundable under any circumstances. If payment is being made monthly, your first payment is due immediately upon booking & the second payment on or around the same date each month, for a minimum period of 12 months. Your payments and membership will automatically continue after that time, unless you contact us and give at least one month’s notice of your intention to leave the programme beyond your first year of membership.

If instalment payments are not received and no communication has been received to discuss an alternative payment plan, your details may be passed to a collections agent working for, or on behalf of Taz Thornton, or legal proceedings may be taken. Please do contact us at your earliest opportunity to discuss any difficulties with the payment plan to avoid these measures. All payment will be made via our merchant account provider (and you consent to us passing your necessary details to the merchant account provider and to them processing necessary information about you) or directly to our bank account, as notified to you. We reserve the right to run price promotions as we think fit.

If you choose to leave the Programme at any time before the minimum 12 month membership requirement, your fee for one full year will still be payable.

3. Refunds

All memberships for the Programme shall be non-refundable. If you are unable to complete any part of the programme, you are still liable for full payment for the first 12 months, and however long you have remained in the programme without communicating otherwise to us. Please note, if you leave the group, but do not communicate your intention to leave by emailing bookings@TazThornton.com, your payments may still be taken and will not be refundable.

4. Cancellation, Postponement

There may be circumstances in which we need to cancel or postpone part of the Programme or date on which a livestream is to be held and if we do, we shall advise you of this as soon as we possibly can. If, for any reason, we need to close the Programme, you will be informed at the earliest opportunity and your payments ceased.

5. Flexibility

As this is an online programme, you will be able to work at your own pace. You will be able to go back and view videos and tasks at any time, so if you are faced with any timing challenges this should not impede your ability to partake in the programme in any way.

As you have signed up to a continual programme, with a minimum 12-month subscription, it is your responsibility to create the timeframe in which you are able to enjoy the tasks and assignments of the #LifeForce programme. The online information in the Facebook group will remain accessible to members beyond the initial year and so, barring any intervention from the platform host, it is our intention to keep the task posts in the group accessible for as long as you are a member.

Please note, we will not be liable in any way for any closure or amendments to the group platform conducted by Facebook, or its associates, beyond the course year,

5. Your Obligations

If you act in any way which in our opinion is likely to cause any harm, distress or nuisance to any person at the Programme, you will be required to leave and we shall not be liable to refund your Fee or any other payment.

6. Data Protection

We will communicate with you using the contact details provided by you for the purposes of the Programme. You agree that we may send your personal data outside of the European Economic Area (for example to the providers of our CRM system).

7. Governing Law

These Terms shall be governed by English Law and you hereby submit to the exclusive jurisdiction of the English Courts.
